

**Joint Agreed Proposal Regarding Schedule**


BellSouth Telecommunications, Inc. dba AT&T Tennessee ("AT&T Tennessee") and the Consumer Advocate and Protection Division of the State of Tennessee Office of the Attorney General ("CAPD") hereby propose the following schedule:

- AT&T Tennessee Petition Filed – May 28, 2010
- AT&T Tennessee provided non-proprietary CD to CAPD – June 3, 2010
- Hearing Officer Appointed / First Status Conference – June 21, 2010
- Agreed Schedule Due – June 28, 2010
- Discovery:  
Any party may propound discovery (limited to no more than 40 requests) at any time prior to the hearing. Responses to discovery are due seven business days after receipt of service of discovery.
- Intervenor's Testimony in Response to Petition – July 15, 2010
- Petitioner's Rebuttal Testimony – July 22, 2010
- Status Conference – two days prior to hearing to determine whether there is a need for a live hearing or whether the matter can be submitted on the papers
- Hearing (half-day) and closing oral legal argument – during week of July 26, 2010 if needed
- Post-hearing briefs – 2 weeks after hearing (during week of August 12, 2010)
- Directors' Deliberation – August 23, 2010
- Statutory Deadline for Decision – August 26, 2010

The parties request that the Hearing Officer approve the schedule.




