COIN OR COINLESS OPERATED TELEPHONE SERVICE**


This matter came before Chairman Sara Kyle, Director Eddie Roberson and Director Kenneth C. Hill of the Tennessee Regulatory Authority (the "Authority"), the voting panel assigned to this docket, at a regularly scheduled Authority Conference held on June 7, 2010, for consideration of the Application of DSI-ITI, LLC ("Applicant") to be an operator of Customer Owned Coin or Coinless Operated Telephone ("COCOT") service in the State of Tennessee filed on June 4, 2010.


Based upon careful consideration of the Application and of the entire record in this matter, the voting panel finds and concludes that the Applicant has met all the requirements of Tenn. Comp. R. & Regs. 1220-4-2-.43 through 1220-4-2-.45 to provide COCOT service in Tennessee.

IT IS THEREFORE ORDERED THAT:

1. DSI-ITI, LLC is authorized to provide COCOT service within the State of Tennessee and is required to post the Company ID Number 129090 on the display card for each COCOT.

2. This Order shall remain in effect until further order of this Authority.
3. This Order shall be retained as proof of certification with this Authority and may be used to obtain the appropriately tariffed access line from Authority authorized telecommunications service providers.
