Pursuant to applicable Tennessee Statues and the Rules and Regulations of the Tennessee Regulatory Authority and Section 253 of the Federal Telecommunications Act of 1996 ("Act"), Norlight Telecommunications, Inc. ("Applicant") respectfully requests that the Tennessee Regulatory Authority ("TRA") grant Applicant authority to provide competing local telecommunications services, including exchange access telecommunications services, within the State of Tennessee. Applicant is willing and able to comply with all applicable rules and regulations in Tennessee pertaining to the provision of competing local telecommunication services. TCA 65-4-201.

3. Corporate Information:

Applicant is a Wisconsin corporation, that was incorporated in 1991. A copy of Applicant's Articles of Incorporation is attached hereto as Exhibit B. A copy of Applicant's authority to transact business in the State of Tennessee is attached as Exhibit C. The names and addresses of the Principal corporate officers are in Exhibit D. There are no officers in Tennessee. The biographies of the principal officers and any other key technical staff are in Exhibit E.

4. Applicant possesses the managerial, technical, and financial ability to provide local telecommunications service in the State of Tennessee as demonstrated below:

A. Financial Qualifications:

In support of its financial qualifications, Applicant submits its latest financial statements showing its sound position. See Exhibit F. Applicant has been providing telecommunications services since its inception and continued to grow its operations. It is already an IXC in the State of Tennessee and is now looking to expand its operations therein. It will initially focus on the Tennessee schools and libraries market and later, looks to expand into other local market segments. Applicant is not currently planning to offer voice grade services.

The Applicant has adequate financial resources in its own right, but to the extent it may need additional funding, said monies will be tendered by Applicant's parent corporation.

B. Managerial Ability:

As shown in Exhibit E, Applicant has the managerial expertise to successfully operate a telecommunications enterprise in Tennessee.

C. Technical Qualifications:

Applicant will satisfy the minimum standards established by the TRA. The company will file and maintain tariffs in the manner prescribed by the TRA and will meet minimum basic local standards, including quality of service and billing standards required of all LEC's regulated by the TRA. Applicant will not require customers to purchase CPE, which cannot be used with the ILEC systems. As noted in Exhibit E, there are two key employees with engineering backgrounds and several years of telecommunications expertise. Thus, Applicant is certainly technically qualified to provide local exchange service in Tennessee.

5. Proposed Service Areas:

Applicant is already authorized to provide telecommunication services in the following states: California (IXC), Colorado (IXC), Connecticut (IXC), Florida (CLEC & IXC), Georgia (IXC), Illinois (CLEC & IXC), Indiana (CLEC & IXC), Iowa (CLEC & IXC), Kansas (CLEC & IXC), Kentucky (CLEC & IXC), Louisiana (CLEC & IXC), Massachusetts (IXC), Michigan (CLEC & IXC), Minnesota (CLEC & IXC), Missouri (IXC), Nebraska (IXC), Nevada (IXC), New York (IXC), North Carolina (CLEC & IXC), North Dakota (CLEC & IXC), Ohio (IXC), Oklahoma (IXC), Pennsylvania (CLEC & IXC), Rhode Island (IXC), South Carolina (CLEC & IXC), South Dakota (CLEC & IXC), Tennessee (IXC), Texas (IXC), Washington D.C. (CLEC), Washington State (IXC), Wisconsin, (CLEC & IXC)

Applicant has/will have applications pending for new or expanded authority in the following states: Alabama (CLEC & IXC), Arkansas (CLEC), Georgia (CLEC),

Mississippi (CLEC & IXC), Missouri (CLEC), Ohio (CLEC), Texas (CLEC), Virginia (CLEC & IXC), and West Virginia (CLEC & IXC).

Applicant has not had an application denied or revoked.

Applicant proposes to expand its existing authority to also include CLEC authority throughout the State of Tennessee, in all areas that are designated open to competition. Applicant intends to offer its services through the use of its own facilities, resold facilities and through a combination of these provisioning methods.

6. <u>Types of Local Exchange Service</u> to be provided:

Applicant will initially provide leased capacity along its fiber optic network to interexchange carriers ("IXCs"), Competitive access providers ("CAPs"), cable television providers, and competitive local exchange companies ("CLECS"). Applicant will provide leased bandwidth at the following levels: DS-1 through OC-48. At each of Applicant's point-of-presence ("POP") locations, Applicant's fiber is connected to OC-48 transmission equipment in a SONET configuration that provides a high level of diversity and survivability. Applicant supports its network with a centralized control center in Evansville, IN, capable of monitoring network traffic for provisioning and maintenance.

7. Repair and Maintenance:

Applicant understands the importance of effective customer service for local service customers. Applicant has made arrangement for its customers to call it on its toll-free telephone number: (877) 599.3285. In addition customers may contact the company in writing at its company headquarters. The toll-free number will be printed on the customer's monthly billing statements.

Granting of the Application will further the goals of the Tennessee Legislature and further the public interest by expanding the availably of competitive telecommunications services in the State of Tennessee. In addition, intrastate offering of these services is in the public interest because the services will provide Tennessee customers increased efficiencies and cost savings. Authorizing Applicant to provide local exchange telecommunications services will enhance materially the

telecommunications infrastructure in the State of Tennessee and will facilitate economic development.

In particular, the public will benefit both directly, through the use of the competitive services to be offered by Applicant and indirectly, because Applicant's presence in Tennessee will increase the incentives for other telecommunications to operate more efficiently, offer more innovative services, reduce their prices, and improve their quality of service. Grant of this Application will further enhance the service options available to Tennessee citizen for the reasons set forth above.

PRE-FILED TESTIMONY OF LOHN WEBER

- I, Lohn Weber, do hereby testify as follows in support of the application of Norlight Telecommunications, Inc. ("Norlight") for a Certificate of convenience and necessity as a competing telecommunications services provider to provide telecommunication services throughout the State of Tennessee.
- Q: Please state your full name, business address, and position.
- A: My Name is Lohn Weber and I am the President and Chief Financial Officer of Norlight Telecommunications, Inc. My business address is 8829 Bond Street, Overland Park, KS 66214.
- Q: Please briefly describe your duties.
- A: I am the officer with overall responsibility for the company. I manage the day-to-day operations.
- Q: Please describe your business experience and educational background.
- A: I am a graduate of the University of Missouri, Columbia, and have an extensive background in accounting. I am a CPA that, prior to entering the telecommunications industry, worked with a large Midwest regional accounting firm, Baird, Kurtz and Dobson. I have approximately 24 years of accounting experience, with 14 years specifically focused on telecommunications.
- Q: Are all statements in Norlight's application true and correct to the best of your knowledge, information and belief?
- A: Yes
- Q: Please describe the current corporate structure of Norlight.
- A. Norlight is a wholly-owned subsidiary of Kentucky Data Link, Inc.

- Q: Does CLEC A, Inc. possess the requisite managerial, financial, and technical abilities to provide the services for which it has applied for authority?
- A: Yes, Norlight is providing these services in several other states and has a long history of successfully providing telecommunications services to its customers.
- Q: Please describe Norlight's financial qualifications.
- A: Norlight is in a strong financial position and has ample resources to pull form in the event it needs to raise any additional finds.
- Q: Please describe Norlight's managerial and technical qualifications.
- A: Norlight has ample managerial and technical qualifications that demonstrate its ability to provide telecommunications services. It has successfully been providing telecommunications services since its inception in 1991, and it has a talented and proven knowledge base with its associate pool.
- Q: What services will Norlight offer?
- A: Norlight currently has IXC authority in Tennessee and is now looking to expand into some new markets. Our current plan for Tennessee is to enter into the schools and library markets, providing non-voice grade service. Perhaps, once business considerations warrant it, we may potentially look to enter into more traditional types of local service such as offering local dial tone to business and residential customers.
- Q: Will Norlight offer service to all consumers within its service area?
- A: Norlight is currently planning on focusing its sales efforts on securing schools and library business.
- Q: Does Norlight plan to offer local exchange telecommunications services in areas served by any incumbent local exchange telephone company with fewer than 100,000 total access lines?
- A: No
- Q: Will the granting of a certificate of convenience and necessity to Norlight serve the public interest?
- A: Yes. The more companies that provide service in the state will obviously increase competition and in turn help drive down prices.
- Q: Does Norlight intend to comply with all TRA rules, statues, and orders pertaining to the provision of telecommunications services in Tennessee, including those for disconnection and reconnection of service?
- A: Yes
- Q: Has any state ever denied Norlight or one of its affiliates authorization to provide intrastate service?
- A: No.

- Q: Has any state ever revoked the certification of Norlight or one of its affiliates?
- A: No.
- Q: Has Norlight or one of its affiliates ever been investigated or sanctioned by any regulatory authority for service or billing irregularities?
- A: No.
- Q: Who is knowledgeable about Norlight's operations and will serve as Norlight's regulatory and customer service contact?
- A: Anthony D. Gillette will serve as the regulatory contact, and there will is a toll-free number available for general customer service issues and inquiries.
- Q: Please explain in detail Norlight's proposed procedures for responding to information requests from the TRA and its staff.
- A: The TRA will submit a request to our legal department, located at 8829 Bond Street, Overland Park, KS 66214, which will in turn gather the requested information and provide it to the TRA.

SMALL AND MINORITY-OWNED TELECOMMUNICATIONS BUSINESS PARTICIPATION PLAN

Pursuant to T.C.A. §65-5-112, as amended, Norlight Telecommunications, Inc. ("Norlight") submits this small and minority-owned Telecommunications business participation plan (the "Plan") along with its Application for a Certificate of Public Convenience and Necessity to provide competing intrastate and local exchange services in Tennessee.

I. PURPOSE

The purpose of §65-5-112 is to provide opportunities for small and minority-owned businesses to provide goods and services to Telecommunications service providers. Norlight is committed to the goals of §65-5-112 and to taking steps to support the participation of small and minority-owned Telecommunications businesses in the Telecommunications industry. Norlight will endeavor to provide opportunities for small and minority-owned Telecommunications businesses to compete for contracts and subcontracts for goods and services. As part of its procurement process, Norlight will make efforts to identify and inform minority-owned and small businesses that are qualified and capable of providing goods and services to Norlight of such opportunities. Norlight's representatives have already contacted the Department of Economic and Community Development, the administrator of the small and minority-owned Telecommunications assistance program, to obtain a list of qualified vendors. Moreover, Norlight will seek to increase awareness of such opportunities so that companies not otherwise identified will have sufficient information to participate in the procurement process.

II. DEFINITIONS

As defined in §65-5-112.

Minority-Owned Business. Minority-owned business shall mean a business which is solely owned, or at lease fifty-one percent (51%) of the assets or outstanding stock of which is owned, by an individual who personally manages and controls daily operations of such business, and who is impeded from normal entry into the economic mainstream because of race, religion, sex or national origin and such business has annual gross receipts of less than four million dollars (\$4,000,000).

Small Business. Small Business shall mean a business with annual gross receipts of less than four million dollars (\$4,000,000).

III. ADMINISTRATION

Norlight's Plan will be overseen and administered by the individual named below, hereinafter referred to as the Administrator, who will be responsible for carrying out and promoting Norlight's full efforts to provide equal opportunities for small and minority-owned businesses. The Administrator of the Plan will be:

The Administrator's responsibilities will include:

- (1) Maintaining an updated Plan in full compliance with §65-5-112 and the rules and orders of the Tennessee Regulatory Authority.
- (2) Establishing and developing policies and procedures necessary for the successful implementation of the Plan.
- (3) Preparing and submitting such forms as may be required by the Tennessee Regulatory Authority, including the filing of required annual updates.
- (4) Serving as the primary liaison to and cooperate with the Tennessee Regulatory Authority, other agencies of the State of Tennessee, and small and minority-owned businesses to locate and use qualified small and minority-owned businesses as defined in \$65-5-112.
- (5) Searching for and developing opportunities to use small and minority-owned businesses and encouraging such businesses to participate in and bid on contracts and subcontracts.
- (6) Providing records and reports and cooperating in any authorized surveys as required by the Tennessee Regulatory Authority.
- (7) Establishing a record-keeping system to track qualified small and minority-owned businesses and efforts to use such businesses.
- (8) Providing information and educational activities to persons within Norlight and training such persons to seek out, encourage, and promote the use of small and minority-owned businesses.

The efforts to promote and ensure equal opportunities for small and minority-owned businesses are primarily spelled out in the Administrator's duties above. Additional efforts to provide opportunities to small and minority-owned businesses will include offering, where appropriate and feasible, small and minority-owned businesses assistance with technical, insurance, bonding, licensing, production, and deadline requirements.

IV. RECORDS AND COMPLIANCE REPORTS








INTRALATA TOLL DIALING PARITY PLAN
