

BellSouth Telecommunications, Inc., d/b/a AT&T Southeast, d/b/a AT&T Tennessee (“AT&T”), and BLC Management LLC d/b/a Angles Communications Solutions (“Angles”), Tennessee Telephone Service, LLC d/b/a Freedom Communications, LLC d/b/a Freedom Communications USA, LLC (“Freedom”), Budget Prepay, Inc. d/b/a Budget Phone (“Budget Phone”), Image Access, Inc. d/b/a New Phone, and dPi Teleconnect, LLC (“dPi”) (“New Phone”), file this joint status report in accordance with the Joint Motion on Procedural Schedule the


parties filed June 15, 2010, in which the parties committed to submit a progress report to the Authority by November 1, 2010. The Authority approved this Joint Motion in its July 28, 2010 Order.

In that Order, the Authority granted the parties' motion to hold the above-captioned matters in abeyance pending the resolution of similar cases pending in other states (Louisiana, South Carolina, North Carolina and Alabama).

In accordance with the procedural schedules adopted in those other states' cases, the parties have filed both Direct and Rebuttal Testimony on August 27, 2010 and October 1, 2010, respectively. The parties have also conducted depositions of the witnesses on October 20 and 21, 2010. Hearings are scheduled and proceeding in Louisiana on November 4 and 5, 2010, and in South Carolina on December 16 and 17, 2010. The parties are also continuing to work together to schedule hearings in North Carolina and Alabama.
