TAWC's sworn responses to Chattanooga's first discovery requests stated that all referenced documents had been provided, including those that TAWC had designated as "confidential". As you know, this was not true, as TAWC withheld all documents that it had designated "confidential". It is our position that this action violated, inter alia, the Scheduling Order and Protective Order in place in this cause.

As of close of business Friday, none of the withheld documents had been received. Similarly, as of 3:00 p.m. Saturday, no such documents had been received in my office.

We will look forward to discussing these matters with the Hearing Officer Monday.

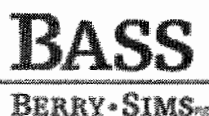
