We have not had the opportunity to compare our notes with yours as to what matters were resolved or remain unresolved from the Monday status conference. However, there was one matter that was not actually discussed in our meeting with you and the other counsel after the status conference: when the Company would produce those items it voluntarily agreed to supplement at the hearing. A reasonable interpretation of the discussions would be that those supplemental responses would be due to be filed by 10 am on Thursday, December 2, along with the formal filing of all the other supplemental responses. Given that we are now in the midst of the Thanksgiving holiday weekend, and the people needed to prepare the supplemental responses to the resolved requests are out of pocket for several days, the Company will need that time to prepare those responses.
