

The Consumer Advocate and Protection Division ("Consumer Advocate"), respectfully provides this notice that it has no opposition to the Motion of Tennessee American Water Company ("TAWC" or "Company") to propound more than forty discovery requests to the Consumer Advocate. While the Consumer Advocate has provided thousands of pages of testimony, workpapers, and documents relied upon with the submission of its pre-filed direct testimony, the Consumer Advocate agrees with the Company that a limit of forty discovery requests, including sub-parts, is sometimes insufficient in a large and complicated rate case. Moreover, opposition of such motions does little but cause procedural delays and incurs needless cost.
