CLEC applicants are required, by statute, to demonstrate their managerial, financial and technical abilities to provide the services for which they seek authority. To assist the Authority in its review of Capital Communications Consultants, Inc.'s application for Certificate of Convenience and Necessity to provide competing local exchange and interexchange telecommunications services in Tennessee, you are requested to provide the following information:

- 3) Since the last response from Capital Communications Consultants, Inc., has the company added additional staff with technical and managerial experience in the telecommunications industry? If so, please provide resumes for those individuals.
- 4) Has Capital Communications Consultants, Inc. been subject to any complaints from the Better Business Bureau in any state? If so, list the states where complaints have been filed, the nature of the complaints, and how they were resolved.
- 5) Is Capital Communications Consultants, Inc. currently affiliated with, have any previous affiliation with, or does the company share any employees or officers or previous employees or officers, or registered agents with any of the following companies: EWP Communications, LLC, Benefits Management Service Branch, Prepaidworx, LLC, True Wireless, LLC or Benson Communications?
- 6) In the states where Capital Communications Consultants, Inc. is providing telecommunications services, provide information regarding consumer complaints filed against the company with any state or federal agency within the past two (2) years. Specify the type of complaint and how it was resolved.

Please provide the above information by August 31, 2012. In accordance with TRA Rules, please submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version and reference Docket No. 10-00198 on the correspondence.
