

**Answer:** Yes, the Applicants have filed similar applications in the following states: California, Colorado, Delaware, Georgia, Indiana, Maryland, Minnesota, Mississippi, New Jersey, New York, Pennsylvania, Texas, Utah and Virginia. These applications currently are pending. The Applicants filed similar notices in the following states: Alabama, Arizona, Connecticut, District of Columbia, Florida, Illinois, Kentucky, Louisiana, Massachusetts, Michigan, Nevada, North Carolina, Oregon, South Carolina, Washington and Wisconsin. No further action will be taken in these notice states.

- 2) Have the applicants filed a similar application with the FCC? If so, list any action taken and the docket number. If a schedule to complete the review of the filing has been established by the FCC, provide such with your response.

**Answer:** Yes, the Applicants have filed a similar petition with the FCC on October 15, 2010. The FCC issued public notice of the domestic transfer application on November 1, 2010, WC Docket No. 10-216. Automatic approval of the domestic transfer application is expected to be on December 2, 2010. The FCC has not yet issued public notice of the international transfer application.

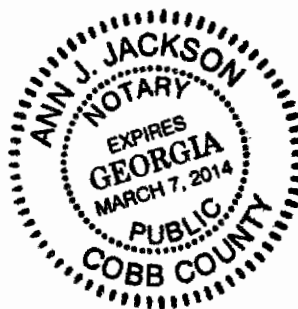
