Petition of Atmos Energy Corporation for Approval Nunc Pro Tunc, of Negotiated Franchise Agreement with the City of Elizabethton, Tennessee.

The Authority has scheduled a Hearing in the above-captioned proceeding pursuant to Tenn. Code Ann. §65-4-107 for Monday, January 24, 2011 beginning at 1:00 p.m. in the Hearing Room on the Ground Floor at 460 James Robertson Parkway, Nashville, Tennessee. The Hearing will be conducted before the voting panel in this case, Chairman Mary H. Freeman, Director Kenneth C. Hill and Director Sara Kyle and will be held in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code §4-5-101 et seq. All parties are entitled to be represented by counsel.

The purpose of the Hearing is to consider the Petition of Atmos Energy Corporation seeking approval Nunc Pro Tunc, of the negotiated franchise agreement between Atmos Energy Corporation and the City of Elizabethton, Tennessee. A franchise fee of 5% (to be collected by Atmos and paid to the City of Elizabethton) will apply to all bills rendered by Atmos Energy Corporation to all classes of customers in the City of Elizabethton. The total franchise fee requested by the City for an average residential customer is expected to be approximately \$32 per year.
