AMENDMENT TO JOINT PETITION

COMES NOW, Navitas TN NG, LLC, by and through counsel, and hereby submits the following certain amendments to the Joint Petition filed in this matter:

1. Following the introductory paragraph and prior to paragraph 1 add the following new paragraph:

"In addition, Navitas TN NG, LLC requests approval pursuant to T.C.A. Section 65-4-109 of the financing arrangements for its acquisition of these certain gas utility systems."

- 2. Following paragraph 29 on page 10, the following new paragraph 30:
 - "30. Premised on the commitment of NALLC and its affiliate Navitas to assisting and keeping rural communities viable, and having shown this commitment through their investment in rural America, in December 2009, the owners of NALLC secured a USDA B&I Rural Development loan for the purpose of acquiring natural gas properties, such as the Gasco properties located in Tennessee. When the loan was approved, a \$1.5 million acquisition line was put in place for future use. A copy of the document reflecting this loan is attached as Exhibit J and marked CONFIDENTIAL. Navitas intends to draw down six-

hundred ten-thousand five-hundred dollars (\$610,500.00) to pay for the portion of the Gasco properties located in Tennessee. This amount will be paid at closing which will occur subsequent to the necessary regulatory approvals, all in accordance with the Order issued on October 21, 2010 by the United States Bankruptcy Court, Southern District of Ohio, Eastern Division authorizing and approving NALLC's bid to acquire the Gasco Utility Systems in Tennessee and Kentucky. The Bankruptcy Court Order was attached to the Application filed in this cause marked as Exhibit B. A requirement of the loan documents is that all properties, including the Gasco properties, purchased with loan funds are pledged as security for the loan. In addition, the owners, Mr. Richard Varner and Mr. Thomas Hartline, are guarantors for the loan."

- 3. Prior to the last paragraph in which relief is requested (paragraph 5 on page 11, renumber that paragraph to be paragraph 6 and insert the following new paragraph 5:
 - "5. Approving pursuant to T.C.A. Section 65-4-109, the financing arrangements as described in the petition of Navitas for its acquisition of these certain utility systems."
