**NOTIFICATION OF NAME CHANGE**

This petition is to notify the Authority, pursuant to TRA Rule 1220-4-1-.08(1), that Telcove Operations, Inc. has changed its registered business name to Telcove Operations, LLC. A Certificate of Authorization from the Secretary of State showing the company's new name is attached.

Because the only change in the registered name is from "Inc." to "LLC," the company asks that the Authority waive the customer notification requirement. See Rule 1220-4-1-.08. ("At its own discretion, the Authority may waive any of the requirements [related to a name change] for good cause.") The name change from "Inc." to "LLC" is not likely to be noticed by any customer. On the other hand, sending a letter to each customer of this pro forma change could cause confusions and questions about the reason for the notice. Finally, the expense of mailing individual notice to each customer is unwarranted under the circumstances. Therefore, the company asks that the notice requirement be waived.

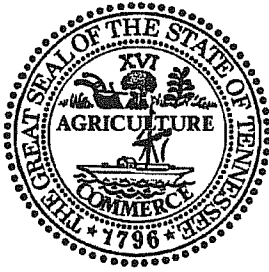
