PETITION FOR EMERGENCY RELIEF

COMES NOW, Petitioner Navitas TN NG, LLC ("Navitas"), by and through counsel, and respectfully submits this Petition for Emergency Relief to the Tennessee Regulatory Authority ("TRA" or "Authority") requesting approval to impose certain customer services charges defined herein on its customers subject to the TRA's jurisdiction and authority pursuant to Tenn. Code Ann. §§65-5-101 and 65-5-103. In support of its Petition, Navitas states as follows:

- 1. Navitas TN NG, LLC ("Navitas") is a Tennessee limited liability company. Navitas' principal place of business is 18218 East McDurmott, Irvine, California 92614. Navitas Assets, LLC ("NALLC") is the parent company of Navitas and is a Delaware limited liability company.
- 2. Navitas is engaged in furnishing natural gas service to approximately 551 customers residing in Tennessee located in: 1) Campbell County, Tennessee and Whitley County, Kentucky (the Jellico System); 2) Pickett County, Tennessee (the Byrdstown System) and; 3) Fentress County, Tennessee (the Fentress System). Navitas also furnishes natural gas service to approximately 145 customers located in Clinton County, Kentucky (the Albany System).

- On December 30, 2010, the Authority issued an Order approving the Joint 3. Petition and the Amendment to the Joint Petition filed on November 17, 2010 and December 10, 2010, respectively, of Navitas and Gasco Distribution Systems, Inc. ("Gasco") (collectively, the "Petitioners"). The Petitioners sought Authority approval of: (1) the transfer of control of gas utility systems of Gasco to provide retail gas utility services in Jellico, Campbell County, Byrdstown, Pickett County and Fentress County, Tennessee and Whitley County, Kentucky deriving from the Certificate of Public Convenience and Necessity issued by the Authority's predecessor, the Tennessee Public Service Commission and related orders, approvals, and actions of the Authority of its predecessor; (2) the transfer of franchise agreements including the agreements between Gasco and the City of Byrdstown, Gasco and Pickett County and the City of Jellico to provide utility service in Jellico, Byrdstown and Pickett County, Tennessee and (3) the financing arrangements of Navitas. Gasco had filed for Chapter 11 bankruptcy protection — Case No. 09056171 - in the United States Bankruptcy Court ("Bankruptcy Court") for the Southern District of Ohio, Eastern Division and operated as Debtor in Possession until the acquisition was approved by the Authority.
- 4. Navitas has adopted the existing tariffs of Gasco for its natural gas operations. The existing tariffs, attached hereto as **Exhibit A** do not contain a customer service charge. Without a customer service charge to compensate for the low usage during the warmer months, when natural gas usage is non-existent or very low, Navitas will be operating at a revenue deficiency as set forth in the attached schedules. A copy of the redacted Schedules are attached hereto as **Exhibit B** and marked **CONFIDENTIAL**.
- 5. Navitas requests the Authority to approve the attached red-lined and clean tariff sheets (Exhibit C) for its Tennessee operations in order for the company to reduce its projected

operating lossess from \$159,000 to \$62,000. A copy of the redacted Schedules reflecting anticipated revenues based on the new rates are attached hereto as **Exhibit D** and marked **CONFIDENTIAL.**

- 6. Navitas seeks the above referenced emergency relief because the existing rates and charges do not provide sufficient revenue to cover the costs incurred to operate the Byrdstown, Jellico and Fentress systems.
- The new rates. Navitas is mindful that the Authority needs to review actual numbers, data and information regarding the Navitas TN gas distribution system and make such tariff modifications as deemed necessary by Staff to update the existing tariff. The prior owner, Gasco, did not provide Navitas with accurate and complete data regarding the system. Therefore, Navitas plans to file a full rate case once it has operated and obtained actual information for a complete twelve (12) month period. Since Navitas acquired the former Gasco system and began operating in January, 2011; it anticipates that it will be prepared to file its rate case in early 2012.
- 8. Navitas respectfully requests that the Authority not require a bond for such emergency relief.
 - 9. Navitas requests this emergency relief to be effective upon Authority approval.
