Dear Chairman Freeman:

On behalf of Primus Telecommunications, Inc. ("Petitioner"), this letter is submitted in response to Data Request No. 1, dated June 2, 2011. Specifically, Petitioner responds to the following questions:

Question 1: Indicate if the financing transaction described in the *Petition* will result in a transfer of certificates, authorizations, assets or customers.

Response: The financing transaction is not expected to result in the transfer of certificates, authorizations, assets or customers.

Question 2: Provide a copy of the terms and conditions of the financing transaction described in the *Petition*.

Response: In response to this data request, Petitioner provides confidentially and under seal a copy of the confidential terms and conditions of the financing transaction as Exhibit 1.
