



Dear Ms. Dillon:

ALEC, Inc. hereby requests approval of a change of its name to ALEC, LLC. ALEC has submitted an original and four copies of this request along with a \$25 application fee. ALEC. Inc. is authorized to provide local exchange and interexchange services pursuant to its certificate of public convenience and necessity granted by the Tennessee Regulatory Authority in its Order dated May 11, 1999 in Docket No. 98-00599. On July 20, 2010, ALEC filed a notification of its intent to operate pursuant to market regulation. The company has now completed the applicable requirements to change its name to ALEC, LLC:

- ALEC has changed its name to ALEC, LLC with the Office of the Tennessee Secretary of State in compliance with the requirements of Tenn. Code Ann. §§48-14-103, 48-54-103, 48-207-103, or 61-2-103, as evidenced by the Acknowledgement of Conversion in the Exhibit 1 hereto.
- ALEC has also changed its name in its surety bond obtained pursuant to Tenn. Code Ann. § 65-4-125, as evidenced in Exhibit 2 hereto.
- In Exhibit 3, ALEC has provided a copy of the notice that it has sent to its Tennessee local
 exchange and interexchange services customers for the purpose of informing them of the name
 change.
- ALEC does not intend to use more than one business name for its telecommunications services
 offered within Tennessee.

Based on the foregoing, ALEC respectfully requests that the TRA grant this request. If you have any questions, please do not hesitate to contact me.



The undersigned hereby forms a Kentucky limited liability company pursuant to the Kentucky Limited Liability Company Act, KRS Chapter 275 (the "Act"), as follows:


- 1. ALEC, Inc. (the "Corporation") was converted to a limited liability company pursuant to a Plan of Conversion. The name of the limited liability company (the "Company") shall be ALEC, LLC.
 - 2. The former name of the Corporation being converted was ALEC, Inc.
- 3. Any assumed names of the corporation are inactive or have been cancelled.
- 4. There are 1,000 shares of common stock of the Corporation issued and outstanding. The sole shareholder of the Corporation was entitled to cast 1,000 votes on the Plan of Conversion. There are no other voting groups. The Plan of Conversion was approved by the sole shareholder and all of the members of the Board of Directors of the Corporation.
- 5. The street address of the Company's initial registered office shall be 400 West Market Street, Louisville, Kentucky 40202. The name of the Corporation's initial registered agent at that office shall be FBT LLC.

- 8. The existence of the Company will be perpetual, except as provided in the Company's Operating Agreement.
