Dear Mr. Foster:

In accordance with your letter of July 15, 2011, and pursuant to the provisions of Tennessee Code Annotated § 67-6-222, enclosed is information pertaining to the required revision of business rates, in order to flow through tax equity credits, for the above-named CenturyLink company. These revisions in rates are applicable to the period starting October 1, 2011, through September 30, 2012.

Enclosed, under Proprietary Cover, is an original and 13 copies of the work sheets and calculations supporting the required customer flow through requirements for the current and past, cumulative periods for CenturyTel Acquisitions, LLC d/b/a CenturyLink Acquisitions ("CenturyLink").

The attached information shows that CenturyLink will flow through its net tax savings of \$3,081 for the period October 1, 2011 through September 30, 2012. This amount will be passed back to CenturyLink's customers through reduced rates, effective with the implementation of the attached draft tariff, and the monthly recurring rate credit reductions shown therein. This flow through requirement includes an estimated \$5,602 that will be flowed through via reduced rates, using the current promotional discounts currently in effect, through September 30, 2011, as well as all necessary true-ups carried over from 2010.

5.2 Basic Line Service\*
