SIXTH AMENDMENT TO CERTIFICATE OF FRANCHISE AUTHORITY

On August 5, 2011, TDS Telecom filed its application for a state issued certificate of franchise authority pursuant to the terms of the Competitive Cable and Video Services Act (“CCVSA”). On August 17, 2011, the Tennessee Regulatory Authority (now the Tennessee Public Utility Commission) granted a Certificate of Franchise Authority to TDS Telecom Service Corporation (“TDS”).

TDS files its Sixth Amendment to add the following municipalities and unincorporated areas to its original application of municipalities and unincorporated areas. The added locations are all within TDS Telecom’s incumbent local exchange (“ILEC”) telecom service area.

Locations as follows:

1. Vonore – Monroe and Loudon Counties (see map)
2. Town of Vonore – Monroe County

TDS has provided a copy and notice of this amendment filing to the affected municipalities and counties.

TDS will comply with all requirements regarding these additional locations to the same extent as set forth in its original (August 5, 2011) application filing and as granted on August 17, 2011.

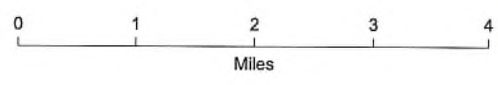
