**ORDER APPROVING REQUEST OF TENNESSEE TELEPHONE COMPANY  
FOR EXPEDITED REVIEW OF GROWTH CODE DENIAL  
AND REVERSING CENTRAL OFFICE CODE DENIAL**

This matter came before Chairman Eddie Roberson, Director Kenneth C. Hill, and Director Sara Kyle, the voting panel of the Tennessee Regulatory Authority (“TRA” or the “Authority”) assigned to this docket, at a regularly scheduled Authority Conference held on September 12, 2011 for consideration of the *Petition for Expedited Review of Central Office Code Denial* filed by Tennessee Telephone Company (“Tennessee Telephone”) on August 15, 2011.

On July 21, 2011, Tennessee Telephone submitted an application to the Pooling Administrator for the purpose of obtaining additional numbering resources to establish a Location Routing Number (“LRN”) for the purpose of establishing a new switch in the LaVergne Rate Center (the “Rate Center”). NXX assignment guidelines permit the assignment of additional codes only after a carrier demonstrates that a rate center has a 75% utilization rate and that its estimated exhaust date does not exceed six months.<sup>1</sup> Because the Rate Center’s utilization rate is currently approximately 63% and the estimated exhaustion date is approximately 61 months, the Pooling Administrator denied the application by Tennessee Telephone. On August 15, 2011, Tennessee Telephone filed a request asking the TRA to review the denial of the Pooling Administrator.


The Federal Communications Commission ("FCC") has authorized the Authority to review the Pooling Administrator's denial of a numbering application.<sup>2</sup> Specifically, the FCC has stated that a state commission may overturn a decision of the Pooling Administrator when "a carrier demonstrates that it has received a customer request for numbering resources in a given rate center that it cannot meet with its current inventory"<sup>3</sup> or, as in this case, when a company installs a new switch and must establish an LRN.<sup>4</sup> After consideration of the facts contained in the record, the public interest, and this agency's responsibility to foster competition in the telecommunications industry,<sup>5</sup> the panel voted unanimously to approve the request of Tennessee Telephone and reverse the Pooling Administrator's denial of Tennessee Telephone's request for additional numbering resources in the Rate Center.

**IT IS THEREFORE ORDERED THAT:**


1. The Pooling Administrator's decision to deny Tennessee Telephone Company's request for additional numbering resources is reversed as stated herein.
2. The Pooling Administrator is ordered to assign one (1) NPA-NXX to Tennessee Telephone Company for the LaVergne rate area served by Switch Identification No. LVRGTNXARS0.
