## Dear Chairman Hill:

On December 22, 2011, Piedmont Natural Gas Company, Inc. ("Piedmont") filed a Stipulation and Settlement Agreement ("Settlement Agreement") between Piedmont and the Consumer Advocate and Protection Division ("Consumer Advocate") resolving all issues in the above-referenced proceeding. This Settlement Agreement was subsequently approved by the Authority at a hearing held on January 23, 2012. Piedmont recently discovered that two column headings on Attachment C to the Settlement Agreement (Heat Sensitivity Factor and Base Factor) had been inadvertently inverted when that Schedule was produced. In order to correct this error, Piedmont has revised Attachment C to reflect the correct column headings. Piedmont has conferred with the Consumer Advocate regarding the need to correct Settlement Attachment C and understands that they have no objection to the filing of Revised Settlement Attachment C.
