**FIRST AMENDMENT TO
CERTIFICATE OF FRANCHISE AUTHORITY**

On August 30, 2011, Spring City Cable TV, Inc filed an application for a state-issued certificate of franchise authority pursuant to the terms of the Competitive Cable and Video Services Act (the "Act").

On September 12, 2011, the Tennessee Regulatory Authority granted a Certificate of Franchise Authority to Spring City Cable TV, Inc.

Spring City Cable TV, Inc. files this FIRST Amendment to add the following municipalities and unincorporated areas within counties to the areas listed in the original application to be served in whole or in part by Spring City Cable TV:

Unincorporated areas of Roane County, Tennessee

Spring City Cable TV has provided a copy of this amendment to the County Executive of Roane County and will comply with all applicable notice requirements. In addition, Spring City Cable TV, Inc. will comply with all requirements regarding the additional locations to the same extent as set forth in its original application.


As Required in Section 7-59-305(c)(3) of the Competitive Cable and Video Services Act, Spring City Cable TV, Inc. intends to begin to offer video services for purchase in the areas indicated above within 24 months of the date of the Commission's acceptance of this amendment.

Spring City Cable TV, Inc. agrees to comply with all provisions of the Act, including, without limitation, the nondiscrimination and service deployment provisions of the Act.

Based on the population of the area designated above, Spring City Cable TV, Inc. hereby submits the required fee of two hundred fifty dollars (\$250.00) with this Amendment.
