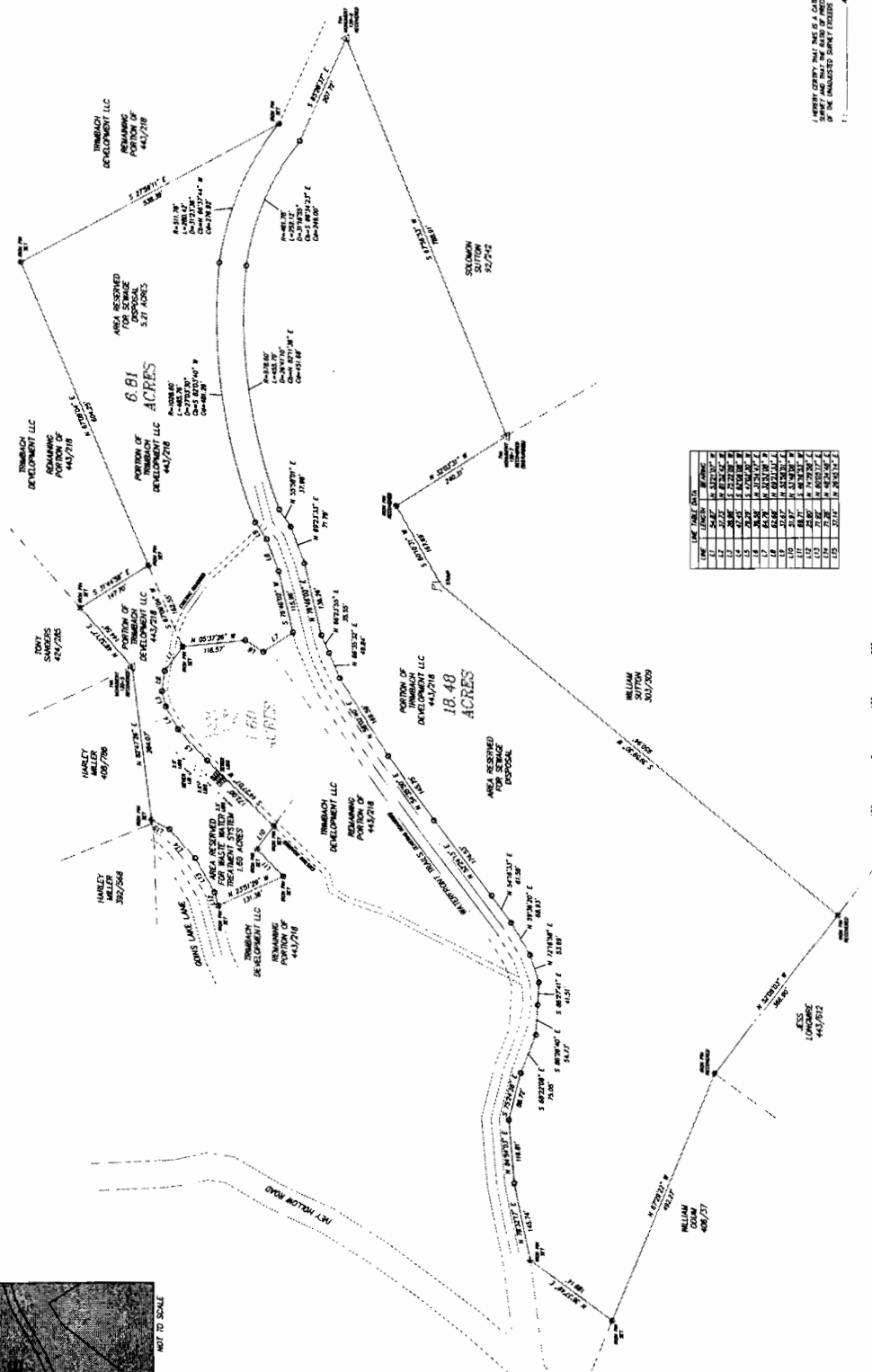
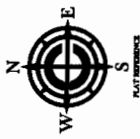
Did I put the cost of the TDEC permit in the expenses? I think it is around \$1,800 but can confirm if needed.
