Dear Ms. Dillon:

On behalf of DSLnet Communications, LLC and DIECA Communications, Inc. (collectively, the "Petitioners"), enclosed please find an original and thirteen (13) copies of the above-referenced Response to Data Request No. 1.

Applicants request confidential treatment of the number of DSLnet customers provided in Attachment A. This Attachment contains commercially sensitive and competitively significant information that is not otherwise released to the public. Unrestricted availability of this information would provide competitors with knowledge that would be otherwise unavailable and could place Applicants at a competitive disadvantage. Confidential and trade secret treatment is therefore required to avoid commercial and competitive injury.

Have the Applicants filed similar applications or notices in other states? If so, provide a listing of states and action taken.

Response:

2. Provide a copy of the self-certification letter filed with the FCC in CC Docket No. 00-257 regarding customer transfers.

Response:

None of the services provided by DSLnet are regulated by the FCC's anti-slamming rules as they are enhanced information services (high speed access to the Internet). As such, DSLnet does not plan to file a self-certification with the FCC in Docket No. 00-257, as the FCC's requirement is inapplicable to the services being provided.

3. Provide the number of customers that DSLnet Communications, LLC ("DSLnet") currently serves in Tennessee.

Response:

Please see CONFIDENTIAL <u>Attachment A</u>. DSLnet emphasizes that the company does not provide any regulated intrastate telecommunications services to any of its Tennessee customers. All of the customers located in Tennessee are provided interstate high speed access to the Internet.

4. Will all DSL.net customers in Tennessee be transferred DIECA Communications, Inc. d/b/a Covad Communications Company?

Response:

Yes. Pursuant to the company's contracts with these customers, they will be transferred to DIECA following the proposed Transactions. Again, the Petitioners emphasize that none of these customers are provided local exchange, intraLATA or interLATA services by DSLnet, but rather high speed access to the Internet.

5. Provide a customer notice letter per TRA Rule 1220-4-2-.56(2)(d).

Response:

The Petitioners respectfully submit that because DSLnet does not provide local exchange, intraLATA, interLATA, or any other intrastate regulated telecommunication service to its customers in Tennessee, the requirements of TRA Rule 1220-4-2-.56(2)(d) are inapplicable. The Petitioners nonetheless intend to provide customer notice of the transfer pursuant to their contractual obligations, a sample of which is provided hereto as <u>Attachment B</u> for informational purposes. The Petitioners respectfully submit that the sending of an additional notice under TRA Rule 1220-4-2-.56(2)(d) will result in customer confusion as the services being provided are not the services covered under that rule, and as such, the Petitioners respectfully submit that the Authority's anti-slamming rules are inapplicable to the Transaction.
