This communication is in response to Docket 1100198, a rate increase for Berry's Chapel Utility, Inc. (BCUI) which will affect all homes in Cottonwood Subdivision. We are homeowners in Cottonwood. A hearing for this increase will take place on 6/7/2012.

In reading testimony in the docket by James Ford (secretary-treasurer of BCUI) on 5/15, I understand the increase is to cover operation losses of \$763,206 from 2009-2011 and \$200,000 for flood damage losses. It states the rate increase would put them as the 3rd most costly sewer treatment company in the state.

BCUI has a reputation in our neighborhood of not communicating information when asked, and trying to create a non-profit utility to avoid regulation by the TRA. We still have \$80.00 on our bill every month from BCUI that we will not pay due to \$20/month unauthorized monthly charges in 2011. We did pay them \$20 on the December 2010 bill, only because our water/sewer bill was on autopay with our checking account. They have not refunded us our \$20, as requested.

Please act in our best interest and find out if the expenses and financial accounting by BCUI is actually true and correct. Our sewer bills already are just very slightly less than our water bill. This rate increase will in the long run affect the value of homes in Cottonwood subdivision.
