## MOTION TO REMOVE "CONFIDENTIAL" DESIGNATION

Pursuant to Section 7 of the Proprietary Order entered in this docket on October 5, 2012, Pay-Tel Communications, Inc. asks that the Hearing Officer remove the "Confidential" designation from the two contracts filed late yesterday, October 8, 2012, by Telmate in response to Pay-Tel's discovery questions. The only item in either contract that is arguably confidential is one figure in Section 4.A. of the contract between Telmate and Legacy International. That figure, which is used to calculate how much Telmate pays for Legacy's billing services, can easily be redacted and the rest of the contract made a public document. The other contract, which is between Telmate and AireSpring, contains no pricing or other information which meets the TRA's definition of "confidential" material.

This is the third time that Telmate has filed "Confidential" documents that, upon examination, contain little or no confidential information. For the third time, the Hearing Officer

should require Telmate to refile the documents without the "Confidential" designation, except for the redaction of the percentage figure in Section 4.A. of the Telmate-Legacy contract.

Since this case is scheduled to be heard during the TRA's conference agenda on October 15, 2012, Pay-Tel asks that the Hearing Officer rule on this request on or before October 12, 2012, the last business day before the conference.
