I am writing in response to your July 9, 2012 letter requesting the following additional information to assist the Authority in reviewing Telmate's application in the above docket.

1) In the Data Response to Question 3 filed on December 19, 2011, Telmate indicated that authorization was pending in Alabama and Wisconsin, and that Telmate expected to file applications in Indiana, Nebraska, and New York. What is the current status of Telmate's applications in Alabama and Wisconsin? Also, has Telmate filed applications in any other states? If so, what is the status of those applications?

RESPONSE: Telmate's applications in Alabama, Wisconsin, Indiana, and Nebraska were all approved within approximately 2 months from the date Telmate's application was filed in each state. Telmate did file for approval in New York on February 12, 2012, but the company has since been advised by New York PSC staff that the services Telmate offers are not regulated in New York. Telmate withdrew its New York filing on April 25, 2012. Telemate has not filed any additional applications.
