By Stipulation dated November 4, 2011 in Docket Nos. 11-00137 and 11-00158, the parties agreed to brief the question of whether asset management fees received by Atmos during the audit period are to be included in the capacity management incentive calculation. That question is now before the Tennessee Regulatory Authority in this Docket. In order to allow additional time for the parties to discuss possible resolution of the matter, the parties have agreed to amend that briefing schedule as follows. The parties will file opening briefs on this question no later than **February 22, 2012**, and reply briefs no later than **March 14, 2012**. 
