Petition

XO Communications Services, Inc. ("XOCS") and Nextlink Wireless, Inc. ("Nextlink" and, together with XOCS, the "Petitioners" or "Companies"), by their counsel and pursuant to §1220-4-1-.08 of the Rules ("TRA Rules") of the Tennessee Regulatory Authority ("TRA"), hereby respectfully request that the TRA approve, insofar as necessary, the conversion of the Companies from Delaware corporations to Delaware limited liability companies and the resulting change in the Companies' names, respectively, to XO Communications Services, LLC and Nextlink Wireless, LLC. As discussed below, the effects of these conversions are *pro forma* in nature and almost entirely transparent to customers. To the extent, however, that TRA approval is required for these conversions or the resulting name changes, the Companies request that such approval be granted. Further, as discussed below, the Companies request that, insofar as necessary, the TRA grant a waiver of TRA Rule 1220-4-1-.08 (2)(c).

The Companies

XOCS. XOCS is authorized by the TRA to provide competitive intrastate telecommunications services in Tennessee.¹ The Company is a direct, wholly-owned subsidiary of XO Communications, LLC ("XO LLC"), which in turn is a direct wholly-owned subsidiary of

XO Holdings, LLC ("XO Holdings").² XO LLC, a Delaware limited liability company, is a leading national provider of local and long distance telecommunications services to businesses, large enterprises and telecommunications carriers. XO LLC is authorized by the Federal Communications Commission to provide interstate and international telecommunications services. Through its subsidiaries – primarily XOCS³ – XO LLC is authorized to provide intrastate interexchange services in 49 states and to provide competitive local exchange services in 48 states as well as the District of Columbia.

Nextlink. Nextlink is a direct, wholly-owned subsidiary of XO Holdings. In Tennessee, Nextlink has been authorized as a competitive carrier to provide local exchange and interexchange telecommunications services.⁴ Nextlink offers broadband wireless access services, managed network services, and wireless access solutions for mobile and wireline voice, data, and video applications to wireless and wireline communications carriers, businesses, and government agencies in the U.S. Nextlink is authorized to provide intrastate services in 26 states as well as the District of Columbia.

Through a number of intermediary companies, Carl C. Icahn, a U.S. citizen, holds 100% ownership of XO Holdings, XO LLC and the Companies.⁵

² XO Holdings, formerly a Delaware corporation, similarly was converted into a Delaware limited liability company on August 31, 2011.

XOCS does not operate in Nevada and Virginia, where XO LLC provides service through two additional subsidiaries: Telecommunications of Nevada, LLC and XO Virginia, LLC respectively.

The Companies recently notified the TRA regarding a transaction in which Carl C. Icahn's ownership of the Companies increased from approximately 92% to 100%.

XOCS and Nextlink are located at 13865 Sunrise Valley Drive, Herndon, Virginia 20171, (703) 547-2000. Organizational charts for the Companies, confirming that the conversions have had no effect upon their respective ownership, are provided as *Exhibit A*.⁶

The Transaction

For internal corporate purposes, the Companies have been converted from Delaware corporations into Delaware limited liability companies. In conjunction with these conversions, XOCS and Nextlink's names have been changed, respectively, to XO Communications Services, LLC and Nextlink Wireless, LLC. Under Delaware law, this conversion is treated as a continuation of the original corporate entity. The ownership interests in each entity have been converted from corporate stock to membership interests; however, the entities holding the ownership of XOCS and Nextlink have not changed. XO, LLC continues to hold 100% ownership of XOCS and XO Holdings continues to hold 100% ownership of Nextlink. Carl C. Icahn continues to hold ultimate 100% ownership of both XOCS and Nextlink.

The TRA may note that in the attached charts the allocation of direct ownership interests in XO Holdings varies slightly from that identified in the Companies' August 10, 2011 notice to the TRA of *pro forma* changes to ownership. At the closing of that transaction, there were minor adjustments to the allocation of the direct ownership interests in XO Holdings; however, the overall ownership structure and the ultimate ownership of the XO companies mirror that described in the filing.

Copies of the documentation from the Delaware Secretary of State evidencing the conversions of XOCS and Nextlink into limited liability companies are attached as *Exhibit B*.

Under Delaware law, the date of commencement of existence of the LLCs is the same date that the corporations were originally formed. All of the assets, rights, liabilities and obligations of the corporations become those of the LLCs by operation of law. Although the Companies have changed their legal forms, neither is transferring any assets to a different legal entity or taking on new debt. *See* Section 214 of the Delaware Limited Liability Company Act, 6 Del. C.C. 18, § 214.

The converted entities have been registered with the Tennessee Secretary of State as foreign limited liability companies and thus are qualified to do business in the State of Tennessee.⁹

Procedural Matters

Customer Notice. The conversion of the Companies into limited liability companies does not involve any change whatsoever in the rates, terms or conditions of services provided to customers, or in the facilities used to provide such services. Consequently, the conversions will be essentially transparent to the Companies' customers, except for the minor name change from "Inc." to "LLC." This transparency notwithstanding, the Companies have notified their customers of the name changes via bill messages. ¹⁰

Pursuant to TRA Rule 1220-4-1-.08(3), the Companies respectfully request that the TRA waive any further application of TRA Rule 1220-4-1-.08 (2)(c) to these name changes. The changes to the Companies' names will be minimal and realistically hold no potential for customer confusion. Each entity's name remains exactly as before, except that the corporate form identifier ("Inc.") will change to "LLC." Moreover, grant of a waiver with respect to this requirement would be consistent with past TRA practice.¹¹

Copies of the limited liability companies' registrations with the Tennessee Secretary of State are appended as *Exhibit C*.

The text of the message reads: "XO Communications Services, Inc.," XO International, Inc.," "XO Interactive, Inc.," and "Nextlink Wireless, Inc." have undergone *pro forma* changes in beneficial ownership that are not substantial. In addition, these four companies, respectively, have become "XO Communications Services, LLC," XO International, LLC," "XO Interactive, LLC," and "Nextlink Wireless, LLC." These changes will not affect your XO services or your contract rights and obligations."

Surety Bond. Nextlink maintains a bond pursuant to TRA regulations and will submit confirmation that the name on the bond has been revised accordingly.

Tariff. It is the Companies' understanding that in the process of granting this petition, the TRA will issue directions regarding the submission of revised tariffs to reflect the Companies' name changes.

Public Interest Considerations

The conversions described above will serve the public interest, as they will enhance the strategic and financial flexibility of the Companies. This flexibility will benefit customers of the Companies in Tennessee and elsewhere. At the same time, the conversions and resulting name changes hold no adverse consequences for consumers. But for the change from "Inc." to "LLC" in the Companies' names, the conversions will be entirely transparent to the Companies' customers. There will be no change to the ownership, management or operations of the Companies as a result of this change. There will be no change to the services provided to customers nor to the terms and conditions under which these services are delivered. Finally, there will be no change to the Companies' overall operational and financial qualifications to provide competitive telecommunications services as a result of the conversions.

Summary

Wherefore, XOCS and Nextlink respectfully request that the TRA issue such approval as it deems necessary for the Companies' changes of corporate form and operating name.




