Subject: Protecting Berry's Chapel Utility Customers

T.R.A. DOCKET ROOM

Mr. Attorney General,

I would like to respectfully draw your attention to the unlawful actions and violations of the public interest that are occurring by Berry's Chapel Utility, formerly Lynnwood Utility (collectively, BCU). As stated on your website, Protecting Customers and Protecting Utility Customers, are two of the eight reasons you exist while "working for Tennessee."

We need the Consumer Advocate who represents the interests of Tennessee consumers of the investor-owned sewer company to enforce laws applicable to that utility and establish a healthy balance between regulation, competition and the public interest.

The Tennessee Regulatory Authority (TRA), the agency responsible for regulating Tennessee's investor-owned utility companies, has previously issued rulings on this matter to balance the public interest. BCU is challenging the authority of your office, the TRA and our Tennessee State Government with their lack of compliance in the following areas:

- Illegal Governance Change: TRA Docket #11-00005
- Illegal Service Fee Change: TRA Dockets #11-00005 and #11-00198
- Failure to Comply with Refund Order: TRA Docket #11-00198

As Tennesseans and Consumers, we expect those dispatched by the State and the Governor to wield the authority provided for the public good. It is time for those officials placed in the seat of power to dispatch their duty. We request the following:

- The following Dockets be postponed:
 - TRA Docket No. 11-00180, Berry's Chapel Utility, Inc. to Recover Costs to Repair Flood, Damage and to Refund Customer Service Fees
 - TRA Docket No. 11-00198, Berry's Chapel Utility, Inc. to Change and Increase Rates and Charges
- An independent review or compilation be performed on the BCU financial statements to validate the unlawful investor-owners' financial performance, which is a basis for a rate increase, prior to any additional rate increase hearings
- Enforcement of the Illegal Service Fee Refund to occur immediately: TRA Dockets #11-00005 and #11-00198
- The principals of BCU, Mr. Tyler Ring and Mr. John Ring, be held personally responsible to the fullest extent possible under the law for their unlawful actions in the management of BCU.
