Subject: Berry's Chapel Utility Rate Increase

Chairman Hill,

I am a customer of Berry's Chapel Utility (BCU). Most of BCU's customers are represented by three HOA's. They wish to measure the impact of the recent increase in rates on every class of customer. We know the small customers will experience a fee increase of approximately 300%. The median customer (6,000 gallon/month user) will see their fees increase by 153%. The large users (>19,000 gallons/month) will experience a REDUCTION of fees with the rate structure proposed by TRA.

TRA has data showing average monthly usage across the customer base. Please forward that data to me so the impact on all customer classes may be measured. I assume it is in a spreadsheet that can be emailed. Thanks for your assistance that will allow us to complete the study.
