## THIRD ORDER EXTENDING PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Regulatory Authority ("TRA" or the "Authority") upon the filing of a *Joint Agreed Motion for Extension of Procedural Schedule* ("*Joint Motion*") ConocoPhillips Company ("ConocoPhillips") and by Chattanooga Gas Company ("CGC") on August 2, 2012.
