ORDER GRANTING KINGSPORT POWER COMPANY D/B/A AEP APPALACHIAN POWER'S FURTHER MOTION TO ALTER PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Regulatory Authority ("TRA" or the "Authority") upon a *Further Motion to Alter Procedural Schedule* ("Motion") filed by Kingsport Power Company d/b/a AEP Appalachian Power ("KgPCo") on September 20, 2012. In its *Motion*, KgPCo states that as the parties continue to engage in significant and substantive negotiations, it requests that the deadline for filing rebuttal testimony be extended up to and including November 1, 2012. Further, KgPCo states that Eastman Chemical Company and Air Products and Chemicals, along with EnerNOC, support the *Motion*.

Therefore, finding the request not to be unreasonable, the Hearing Officer hereby orders that the date for filing rebuttal testimony is extended up to and including November 1, 2012.
