JOINT REQUEST FOR ENTRY OF SCHEDULING ORDER

Come Kingsport Power Company d/b/a AEP Appalachian Power ("KgPCo"), Eastman Chemical Company ("Eastman"), Air Products and Chemicals, Inc. ("Air Products"), Demand Response Partners, Inc. ("DRP") and EnerNOC, Inc. ("EnerNoc"), and respectfully submit the following proposed schedule for these combined contested cases for consideration by the Tennessee Regulatory Authority and Hearing Officer Kelly Cashman-Grams:

(1) June 11, 2012:

A. KgPCo would submit a filing which makes the pre-filed direct testimony it filed in Docket No. 12-00012 on February 7, 2012, applicable to Docket No.: 12-00026. In addition, KgPCo would be permitted to file any supplemental testimony deemed appropriate to the two

dockets.

B. Eastman, Air Products, DRP, and EnerNOC would file direct testimony in Docket No. 12-00026 covering all issues and would file testimony responsive to the pre-filed direct testimony previously submitted on behalf of KgPCo in Docket No. 12-00012. This responsive testimony would cover all issues which Eastman, Air Products, DRP, and EnerNOC deem necessary to address the Petition and the pre-filed direct testimony of KgPCo in Docket No. 12-00012, including, but not limited to, any comments, objections, or concerns over the language of and substantive portions of KgPCo's PSDR Tariff and PSEDR Tariff.

(2) June 15, 2012 – August 17, 2012:

A. All parties would be permitted to conduct discovery pursuant to T.R.A. Rule 1220-1-2-.11, except it shall not be necessary for any party to petition for discovery, as the entry of this proposed Scheduling Order would be considered as permission to proceed with discovery during said time period.

(3) August 31, 2012:

A. Deadline for filing any rebuttal testimony (limited to scope of supplemental testimony of KgPCo, filed June 11, 2012, and direct and responsive testimony filed by Eastman, Air Products, DRP, and EnerNOC on June 11, 2012).

(4) September 10-19, 2012:

A. Dates for hearing.




