#### **ORDER ENTERING PROCEDURAL SCHEDULE**

These consolidated matters came before the Hearing Officer upon the *Joint Request for Entry of Scheduling Order ("Joint Request")* filed with the Tennessee Regulatory Authority ("Authority") by Kingsport Power Company d/b/a AEP Appalachian Power ("KgPCo"), Eastman Chemical Company ("Eastman"), Air Products and Chemicals, Inc. ("Air Products"), Demand Response Partners, Inc. ("DRP") and EnerNOC, Inc. ("EnerNOC") on May 4, 2012. In the *Joint Request*, the parties have proposed a procedural schedule to completion.

Upon consideration, the Hearing Officer finds the schedule proposed by the parties to be reasonable and hereby adopts it with the following clarifications: 1) a copy of each discovery request propounded and each response exchanged by and between the parties shall be filed concurrently in the docket file, and 2) while every effort will be made to accommodate the

parties request for a hearing to be set between September 10-19, 2012, the finalization and setting of date(s) for hearings before the Authority are at the direction and discretion of the Panel.
