NOTICE OF HEARING AND ORDER TO APPEAR

IN RE: *Show Cause Proceeding Against David Andrews for Alleged Violations of Tenn. Code Ann. § 65-4-501 et seq.*

David Andrews a.k.a. David Andrews d/b/a Flyaway Group/Corporate Travel Department ("David Andrews" or "Respondent") is hereby ordered to appear before the Tennessee Regulatory Authority ("Authority") for a public hearing to be held during its regularly scheduled Authority Conference on **Wednesday, March 13, 2013 at 1:00 p.m. CST** and show cause, if there be any, why the Authority should not find David Andrews in violation of state law, Tenn. Code Ann. § 65-4-501 et seq., and thereafter issue an Order requiring Respondent to cease and desist immediately the unlawful transmission of unsolicited facsimile advertisements, imposing civil penalties including up to two thousand dollars (\$2000) for *each* violation, and other appropriate sanctions to the maximum extent allowed by law.

This matter will be held in the Hearing Room on the Ground Floor at 460 James Robertson Parkway, Nashville, Tennessee, and conducted by the voting panel assigned to this docket, Vice Chairman Herbert H. Hilliard, Director Kenneth C. Hill and Director Sara Kyle, in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-101 et seq. Failure to appear at this hearing may constitute default and result in adverse action and/or a ruling against Respondent, including entry of an Order that may be used to seek additional relief in any court of competent jurisdiction. Any and all persons having an interest in this matter shall appear and are entitled to be represented by counsel. Any motion to continue or reschedule the date of this hearing must be made in writing and filed with the Office of the Authority Chairman on or before **Thursday, March 7, 2013**.
