
ORDER SETTING REVISED PROCEDURAL SCHEDULE

This matter is before the Hearing Officer upon a request filed with the Tennessee Regulatory Authority ("Authority") on September 14, 2012, by Bristol Tennessee Essential Services ("BTES" or "Applicant Company") with and on behalf of the intervening parties, United Telephone-Southeast LLC d/b/a CenturyLink, CenturyLink of Adamsville, Inc. d/b/a CenturyLink Adamsville, CenturyTel of Claiborne, Inc. d/b/a CenturyLink Claiborne, and CenturyTel of Ooltewah-Collegedale, Inc. d/b/a CenturyLink Ooltewah-Collegedale (together, "CenturyLink"), and the Tennessee Cable Telecommunications Association ("TCTA") (collectively, the "Parties"), to revise the Procedural Schedule issued on August 30, 2012.

In its letter, BTES states that the Parties have agreed to defer consideration of discovery disputes, if any, until after BTES has produced its documents and responses to the first round of discovery. With its letter, BTES attached a revised proposed procedural schedule for the review and consideration of the Hearing Officer. Upon consideration, the Hearing Officer finds the revised schedule proposed by the parties to be reasonable and adopts it without modification.

The Revised Procedural Schedule attached to this Order as **Exhibit A** is adopted in full force and effect.
