10. I have paid all fees required pursuant to Tennessee Supreme Court Rule 19 in connection with the motion for *pro hac vice* admission.



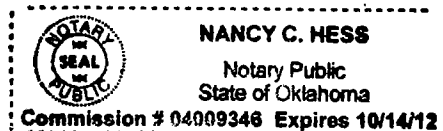
