- 1. I have personal knowledge of the facts stated herein.
- On June 4, 2012, I met with Sam Cooper. Mr. Cooper represented that he was a General Partner of Global Media Management LLC.
- 3. On June 4, 2012, Mr. Cooper took responsibility for Do Not Call violations.
- 4. On June 12, 2012, I emailed Mr. Cooper.
- 5. Mr. Cooper informed our office that his mailing address was 8881Woodmark Drive, Cordova, Tennessee 38018, his email address was sam@globalmediamanagementllc.com, and that his telephone number was (901)387-8507.
- On June 15, 2012, I mailed the Settlement Agreement via certified mail to Mr. Cooper at 8881 Woodmark Drive, Cordova, TN 38018.
