Attached hereto is the Certification Letter of Louise Brown, certifying that Loretto Telephone Company, Inc. (the "Company") (SAC 290570) is in compliance with the requirements of Section 254 (e) and the requirements established by the Commission in *In the Matter of Federal-State Joint Board on Universal Service*, CC Docket Nos. 96-45 and 00-256, Fourteenth Report and Order, Twenty-Second Order on Reconsideration, and Further Notice of Proposed Rulemaking in CC Docket No. 96-45 and Report and Order in CC Docket No. 00-256 (FCC 01-157) (released May 23, 2001) ("Order") and codified at 47 C.F.R. § 54.314. Furthermore, all federal high-cost support, including high cost loop support, local switching support, high-cost support received pursuant to the purchase of exchanges, high-cost model support, and hold harmless support, will be used only for the provision, maintenance, and upgrading of facilities and services for which the support is intended, consistent with 47 U.S.C. § 254(e) of the Telecommunications Act of 1996.

The Company received \$938,706 in Universal Service Funds for the 2011 fiscal year,

High Cost Loop	\$ 4,251
Local Switching Support	\$242,544
Interstate Common Line Support	\$608,499
Safety Net Additive	\$ 83,412

The Company allocated \$1,344,142 to provisioning and maintenance and \$1,017,070 to upgrading of facilities and services for which the support was intended, consistent with 47 U.S.C. § 254(e) of the Telecommunications Act of 1996.

I, Louise Brown, President of Loretto Telephone Company, Inc. (the "Company") do hereby certify under penalty of perjury that the following is true and accurate to the best of my knowledge and belief:
