**APPLICATION TO CHANGE NAME
OF CERTIFICATED CARRIER**

Liberty-Bell Telecom, L.L.C. (“Company”) files this Application with the Tennessee Regulatory Authority and requests approval to change its name to dishNET Wireline L.L.C. (“dishNET”). If the new name is approved, the Company will not do business in Tennessee as “DISH Network Phone & Internet.”

The Company was granted authority to provide competitive facilities-based and resold local exchange, switched exchange access, and non-facilities-based interexchange telecommunications services in Docket No. 11-00201. If the TRA issues a new or amended certificate, the new name should appear as “dishNET Wireline L.L.C.” with “dish” in lower case letters and “NET” in capital letters.

The change in name is not the result of a corporate reorganization or a change of control. Since the Company has not launched services in Tennessee, there will no impact on operations or customers. Since the Company does not have any customers, it also seeks a waiver of any requirement to provide notice of name change to customers in Tennessee.

If the TRA approves this Application, the Company requests permission to file revised tariffs reflecting the name change within 30 days of the effective date of any Order.

(2) Exhibit B: General Surety Rider reflecting the name change

Upon approval of the Application or as otherwise directed by the Commission, the Company will make a compliance filing amending its tariffs.
