## NOTICE TO APPEAR

**IN RE:** *Show Cause Proceeding Against Direct Marketing Travel Services, Inc. for Alleged Violations of Tenn. Code Ann. § 65-4-401 et seq.*

Direct Marketing Travel Services, Inc. ("Direct Marketing" or "Respondent") shall appear before the Tennessee Regulatory Authority ("Authority") during the regularly scheduled Authority Conference on **August 6, 2013 at 9:00 a.m. CDT** and show cause, if there be any, why the Authority should not find Direct Marketing in violation of Tenn. Code Ann. §§ 65-4-401 *et seq.* and, thereafter, proceed to impose civil penalties and sanctions, including but not limited to, an Order requiring Respondent to immediately cease and desist unlawful telephone solicitation, civil penalties of up to two thousand dollars (\$2000) for *each* violation, and other appropriate sanctions allowed by law.

This matter will be held in the Hearing Room on the Ground Floor at 460 James Robertson Parkway, Nashville, Tennessee, and conducted by the voting panel assigned to this docket, Chairman James M. Allison, Vice Chairman Herbert H. Hilliard, and Director David Jones, in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-101 *et seq.* Failure to appear may constitute a default and result in adverse action against Respondent, including entry of an Order that may be used to seek additional relief in any court of competent jurisdiction. Any party having an interest in this matter shall appear and is entitled, at such party's own expense, to be represented by counsel.

Any motion to continue or reschedule the date of this hearing must be made in writing and filed with the Office of the Authority Chairman **on or before Thursday, August 1, 2013**.
