**Joint Proposed Procedural Schedule**


Tennessee Wastewater and Emerson Properties jointly suggest that this matter be set for hearing in November. We anticipate two witnesses, one from Tennessee Wastewater and one from Emerson.



We propose that direct testimony be filed on October 11, 2013 and rebuttal on October 25, 2013. The testimony will address both the complaint and the counterclaim. At this time, Tennessee Wastewater and Emerson do not believe there is any need for formal discovery nor pre-hearing briefs. Informal discovery shall be completed by October 11, 2013. If any party, including the Consumer Advocate, determines that formal discovery is needed, the party may file an appropriate motion with the Hearing Officer including, if needed, a request for adjustment in the filing and hearing dates. Any party, including the Consumer Advocate Division, may file a brief after the hearing. Such filings are due two weeks after the hearing date. No reply briefs may be filed.

It is our understanding that the Consumer Advocate Division does not object to this proposed schedule.


