Zone Telecom, Inc. was previously granted authorization as an operator service provider and/or reseller of telecommunication services (see Docket No. 00-00878, Order dated February 21, 2001). Pursuant to the request filed May 1, 2012 and subsequent Order dated September 13, 2012 (Docket No. 12-00034), Zone Telecom, Inc. was granted approval to change the name under which it provides telecommunication services in Tennessee to Zone Telecom, LLC.

Please be advised that Zone Telecom, LLC has changed its name to ANPI Business, LLC.

Attached hereto, please find a copy of ANPI Business, LLC's Application for Amended Certificate of Authority as acknowledged by the Tennessee Secretary of State. Also enclosed please find a check in the amount of \$25.00 for the applicable filing fee.



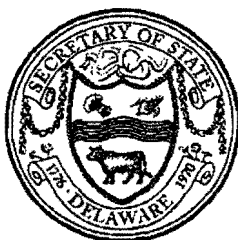



II. DEFINITIONS

As defined in §65-5-112.

Minority-Owned Business. Minority-owned business shall mean a business which is solely owned, or at least fifty-one percent (51%) of the assets or outstanding stock of which is owned, by an individual who personally manages and controls daily operations of such business, and who is impeded from normal entry into the economic mainstream because of race, religion, sex or national origin and such business has annual gross receipts of less than four million dollars (\$4,000,000).

Small Business. Small Business shall mean a business with annual gross receipts of less than four million dollars (\$4,000,000).

III. ADMINISTRATION
