ORDER REQUIRING OPEN BUSINESS DIRECTORY, LTD.,
TO APPEAR AND SHOW CAUSE WHY THE TRA SHOULD NOT
ISSUE A CEASE AND DESIST ORDER, IMPOSE CIVIL PENALTIES, AND SEEK
ADDITIONAL RELIEF AGAINST IT FOR VIOLATIONS OF
TENN. CODE ANN §§ 65-4-501, et. seq.

This matter is before the Hearing Officer upon the Order of the Tennessee Regulatory Authority ("TRA" or "Authority") to determine whether an Order for Show Cause should be issued against Open Business Directory, Ltd. ("Open Business"), and if so, to prepare the matter for hearing before the panel. The Consumer Services Division of the Authority ("CSD") has presented a *Petition* and the *Affidavit of Slayde Warren*, alleging that Open Business has violated Tenn. Code Ann. §§ 65-4-501, et. seq. Based thereon, the Hearing Officer determines that an Order should be issued, and contested case proceeding convened, requiring Open Business to appear before the Authority and show cause why the TRA should not issue a cease and desist order, impose civil penalties and sanctions, and seek appropriate additional relief for violations of State law.

#### **JURISDICTION**

The Authority is specifically authorized and charged, to ensure that the laws of this State as they relate to the Authority's jurisdiction "are enforced and obeyed, that violations thereof are

promptly prosecuted, and all penalties due the State are collected." The Authority is empowered to hear this matter and render an Order pursuant to the powers delegated by the Tennessee General Assembly, including those provided in Tenn. Code Ann. §§ 65-2-106, 65-3-105, 65-4-116, and 65-4-504.

## RELEVANT FACTS

- Open Business transmits/sends, or causes to be transmitted/sent, unsolicited 1. facsimile advertisements to Tennessee consumers.<sup>2</sup>
- 2. Between February 7, 2011 and May 7, 2013, the CSD received complaints from five (5) Tennesseans or Tennessee entities that had received from Open Business, which had sent or caused to be sent, at least twelve (12) unsolicited facsimile advertisements soliciting the purchase of goods and/or services.<sup>3</sup>
- 3. CSD's investigation determined that these Tennesseans or Tennessee entities had no pre-existing business relationship with Open Business.<sup>4</sup>

# **ALLEGED VIOLATIONS OF STATE LAW**

The following actions, alleged to have been performed by Open Business, constitute violations of state law:

A. On at least twelve (12) separate occasions Open Business sent or caused to be sent unsolicited facsimile advertisements to at least five (5) Tennesseans or Tennessee entities.

#### COUNT 1:

Open Business' actions of sending or causing to be sent an unsolicited facsimile

advertisement violates Tenn. Code Ann. § 65-4-502(a) (2013), which states:

No person shall transmit or cause another person to transmit an unsolicited facsimile advertisement. . .

UPON THE FOREGOING INFORMATION AND ATTACHMENTS, as presented by the CSD, the Hearing Officer acting pursuant to the scope of the TRA's regulatory authority granted under Tenn. Code Ann. §§ 65-1-113, 65-2-106, 65-3-105, 65-4-116, and 65-4-502, hereby determines that Open Business should be required to appear and show cause why it should not be found in violation of State law and, upon such finding, the Authority should not immediately issue a cease and desist order, impose civil penalties and sanctions, and seek additional relief to the maximum extent allowed by law.

#### BE IT THEREFORE ORDERED THAT:

Open Business Directory, Ltd., shall appear before the Tennessee Regulatory Authority for a hearing at 1:00 p.m. CST on January 13, 2014, in the Hearing Room on the ground floor of the Andrew Jackson State Office Building located at 500 Deaderick Street, Nashville, Tennessee 37242, and shall show cause why the Authority should not proceed to take action against Open Business Directory, Ltd., for the unlawful actions and omissions alleged against it in this Order, including, but not limited to, the issuance of a cease and desist order and the imposition of civil penalties and sanctions.

Code Ann. §§ 65-5-501, et seq. and, thereafter, proceed to issue an Order requiring that Open Business immediately cease and desist unlawful facsimile solicitation, impose civil penalties of up to two thousand dollars (\$2000) for each violation, and seek other appropriate relief or sanctions allowed by law.

This matter will be held in the Hearing Room on the Ground Floor located at 500 Deaderick Street, Nashville, Tennessee, and conducted by the voting panel assigned to this docket, Chairman James M. Allison, Director David Jones, and Director Robin Bennett, in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-101 et seq. Failure to appear may constitute default and result in adverse action against Respondent, including entry of an Order that may be used to seek additional relief in any court of competent jurisdiction. Persons affected by this matter shall appear and are entitled, at their own expense, to be represented by counsel.

Any motion to continue or reschedule the date of this hearing must be made in writing and filed with the Office of the Authority Chairman on or before Wednesday, January 8, 2014. #### PETITION

Comes now the Tennessee Regulatory Authority ("TRA" or "Authority") Consumer Services Division ("CSD") by and through counsel and requests that the Hearing Officer appointed by the Directors on July 15, 2013, issue an Order requiring that Open Business Directory, Ltd. ("Open Business") appear and show cause before the Authority why it should not be found liable for violations of the Tennessee Do-Not-Fax law. The CSD further requests that at the hearing before the Authority that the Directors impose the maximum civil penalty allowed by law and order that Open Business cease and desist sending unsolicited facsimile advertisements to Tennessee consumers.

## **ALLEGATIONS OF FACT**

- 1. Open Business sends unsolicited facsimile advertisements to Tennessee consumers.
- Between February 7, 2011 and May 7, 2013, the CSD received complaints indicating that
   Open Business sent or caused to be sent at least twelve (12) unsolicited facsimile
   advertisements to at least five (5) Tennesseans soliciting them to purchase goods and/or
   services.
- CSD's investigation determined that these Tennesseans had no pre-existing business relationship with Open Business.
- 4. As evidence of the above allegations the CSD submits the Affidavit of Slayde Warren as



well as accompanying evidence (Exhibit 1). The CSD requests that Exhibit 1 be entered into the record in this cause.

## **CAUSES OF ACTION**

5. The facts alleged in paragraphs 1 - 4 constitute a violation of Tenn. Code Ann. §65-4-502.

#### PRAYER FOR RELIEF

- The CSD requests that the Hearing Officer place this matter on the docket for hearing at the January 13, 2013, Authority Conference.
- 7. That at that hearing the Authority issue a cease and desist order barring Open Business from sending or causing another to send unsolicited facsimile advertisements to Tennessee consumers.
- 8. Pursuant to Tenn. Code Ann. §65-4-504 the Authority may impose a civil penalty of up to two thousand dollars (\$2,000) per violation of law.
