REPLY TO THE PETITON FILED IN SUPPORT OF ALLEGATIONS OF VIOLATIONS OF TENN CODE ANN §65-4-501 et seq.

- 1. The Company Open Business Directory Ltd is seeking reconsideration of the Order made against it on January 23rd, 2014 in which the Company was found to be in violation of the above Code and was ordered to pay a fine in the sum of \$24,000.
- 2. The Company was at the time of the hearing unaware of the issue of the Petition and did not have an opportunity of providing any answer to the Petition.
- 3. The Company has now had the opportunity of reviewing both the Petition and the Affadavit of Slayde Warren filed in support thereof and in respect of an alleged twelve violations of sending unsolicted facsimile advertisements stated in the Petition to five (5) Tennesseans.
- 4. The Petition alleges that the Company has violated the above Code concerning the sending of unsolicited fax advertisements which is defined as being "any material advertising the commercial availability or quality of any property, goods, or services, that is transmitted by fax to any person located within the State of Tennessee without such person's prior express invitation or permission, and is transmitted from Tennessee or elsewhere for the purpose of offering the extension of credit or encouraging the purchase or rental of, or investment in, property, goods, or services."
- 5. The said Code does not cover every unsolicited fax transmissions, only advertisements.
- 6. The Company did respond to the letters sent to it by the TRA concerning complaints but advised that no file could be found from the details provided and therefore no contract existed.
- 7.In the case of Chalfant Travel Services a contract was entered into by the business and a copy of the completed and signed Order form is attached to this Reply and marked CTS 1.
- 8. The Company has not violated the above Code in that the Order form received by the businesses was not a form of advertisement as defined in the Code. The Order form received by the business is a Purchase Order Form by definition which does not advertise any service or availability or quality of any services and does not encourage the purchase of any services. A Purchase Order is a request to purchase goods or services The Order form does not advertise services.
- 9. The Purchase Order form sets out the terms should a business wish to order the service and the fees for such service.
- 10.An adversisement can also be defined as "the making of a representation in any form in connection with a trade, business, craft or profession in order to promote the supply of goods or services, including immovable property, rights and obligations". and
- "A notice or announcement in a public medium promoting a product, service, or event or publicizing a job vacancy"
- 11. The Purchase Order Form CTS 1 does not make such representations defined by the Code or generally.
- 12. The Company would therefore plead that for the above reasons it is not in violation of the Tennessee Do-Not-Fax Law as defined within the Code so far as it relates to an unsolicited fax
