First Amendment to Interconnection Agreement

The Interconnection Agreement, dated the 10th day of August, 2005, between Concord Telephone Exchange, Inc., Tennessee Telephone Company, Humphreys County Telephone Company, and Tellico Telephone Company, Inc. (collectively "TDS TELECOM") and Charter Fiberlink - Tennessee, LLC, approved by the Tennessee Regulatory Authority in 05-00239 on November 1, 2005, is hereby amended as follows:

1. Appendix WP (White Pages Directory). Section 2.4 of Appendix WP is hereby deleted in its entirety and replaced with the following:

"2.4 CHARTER shall furnish to TDS TELECOM via a Local Service Request (LSR) or Directory Service Request (DSR) all new, changed and deleted subscriber listing information pertaining to CHARTER End Users located within the local directory scope, along with such additional information as TDS TELECOM may require to prepare and print the alphabetical listings of said directory. CHARTER may provide CHARTER's subscriber listing information to TDS TELECOM for inclusion in the WP directory up to ten (10) days prior to the business office close date. The LSR and DSR service order charges set forth in Appendix PRICING shall apply as follows: (i) if CHARTER provides subscriber list information on an LSR, only the LSR order charge shall apply, and there shall be no additional DSR order charge; and (ii) if CHARTER provides subscriber list information (including new or changed information or a request for deletion of a listing) on a DSR, only the DSR order charge shall apply, and there shall be no additional LSR order charge."

2. Appendix Pricing. Attachment A of Appendix Pricing is hereby deleted and replaced in its entirety with Attachment A-1 attached hereto.
3. Other Terms and Conditions; Effectiveness. The remaining terms and conditions of the Agreement shall remain in effect. This Amendment shall be effective as of the date last signed below.
