JOINT MOTION TO REVISE PROCEDURAL SCHEDULE

Berry's Chapel Utility, Inc. ("Berry's Chapel") and the Consumer Advocate and Protection Division ("Consumer Advocate") (collectively "the Parties") respectfully submit this joint motion requesting that the procedural schedule in this docket be modified and continued as reflected in the proposed revised procedural schedule attached hereto and incorporated herein by reference. The proposed revised schedule essentially provides for a thirty-day continuance, with a revised target hearing date set for the date of the July 2014 Authority Conference.

On March 13, 2014, the members of Berry's Chapel elected a new Board of Directors. The Parties submit that the requested continuance would foster a more efficient and orderly progression of this docket by giving the Parties a reasonable opportunity to address the recent change in control of Berry's Chapel and to determine the effect, if any, this change may have on the pending request for rate relief.

Berry's Chapel acknowledges that if the requested continuance is granted, the Authority may be unable to render a final decision on its petition within six months from the date the

petition was filed on January 16, 2014. Accordingly, Berry's Chapel expressly waives for a period of thirty days its rights under Tenn. Code Ann. § 65-5-103(b)(1) to place the proposed rate increase, or any portion thereof, into effect at the expiration of six months from the date the petition was filed. Pursuant to this waiver, the six-month deadline will expire on August 16, 2014.

Wherefore, Berry's Chapel and the Consumer Advocate jointly request the Authority to grant their motion to revise the procedural schedule.
