ORDER ESTABLISHING REVISED PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Regulatory Authority ("TRA" or "Authority") upon a *Joint Motion to Revise Procedural Schedule* ("*Joint Motion*") filed by Berry's Chapel Utility, Inc. ("Berry's Chapel" or "Utility"), and the Consumer Advocate and Protection Division of the Office of the Attorney General (collectively, the "Parties"). In the *Joint Motion*, the Parties request an approximately 30-day continuance of the procedural schedule in order to determine the impact on the proceedings, if any, of the election of a new Utility Board of Directors. Further, in consideration of the Parties' request, Berry's Chapel waives, until August 16, 2014, the six-month deadline provided in Tenn. Code Ann. 65-5-103(b)(1).

Upon finding sufficient cause for the request, the Hearing Officer agrees that the deadlines set forth in the procedural schedule should be modified. Therefore, although alteration
