

King's Chapel Capacity, LLC ("King's Chapel" or "Respondent") shall appear before the Tennessee Regulatory Authority ("Authority") during its regularly scheduled Authority Conference at **1:00 p.m. CST on December 1, 2014**, and show cause why the Authority should not find King's Chapel in violation of various provisions of state law, including Tenn. Code Ann. §§ 65-3-106(b), 65-4-115, and 65-4-117(a)(1), and the TRA's Wastewater Rules, Tenn. Comp. R. & Regs. 1220-04-13-.07(2), (5) and (7)(b), and, upon such finding, issue an Order requiring that King's Chapel cease and desist its unlawful acts and omissions, imposing civil penalties and sanctions, and any other relief allowed under law.

Vice Chairman David Jones, Director Kenneth C. Hill, and Director Robin Bennett, will conduct the hearing in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-101 *et seq.*, in Hearing Room G.201 on the Ground Floor of the Andrew Jackson State Office Building, **500 Deaderick Street, Nashville, Tennessee**. Failure to appear may constitute default and result in adverse action against Respondent, including entry of an Order to seek additional relief in any court of competent jurisdiction. Any party or interested person may appear and is entitled, at his own expense, to be represented by counsel.

A motion to continue or reschedule the date of this hearing must be made in writing and filed with the Office of the Authority Chairman by **November 24, 2014**.
