PETITION FOR APPROVAL OF THE AMENDMENT TO THE INTERCONNECTION AGREEMENT NEGOTIATED BETWEEN AT&T TENNESSEE AND KENTUCKY DATA LINK, INC.

AT&T Tennessee ("AT&T") and Kentucky Data Link, Inc. ("KDL") file this request for approval of the Amendment to the Interconnection Agreement (the "Agreement") negotiated between the two companies pursuant to Sections 251 and 252 of the Telecommunications Act of 1996, (the "Act"). In support of their request, KDL and AT&T state the following:

- 1. KDL and AT&T have negotiated an agreement for interconnection of their networks, the unbundling of specific network elements offered by AT&T and the resale of AT&T's telecommunications services to KDL. A copy of the Agreement is attached hereto and incorporated herein by reference.
- 2. The parties have recently negotiated an Amendment to the Agreement which changes KDL's name to Windstream KDL, replaces Notice terms with AT&T's current notice language and notice address and includes new effective data language. - 3. Pursuant to Section 252(e) of the Telecommunications Act of 1996, KDL and AT&T are submitting their Agreement to the TRA for its consideration and approval.
- 4. In accordance with Section 252(e) of the Act, the TRA is charged with approving or rejecting the negotiated Agreement between AT&T and KDL within 90 days of its submission.

The Act provides that the TRA may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity.

- 5. KDL and AT&T aver that the Agreement is consistent with the standards for approval.
- 6. Pursuant to 47 USC Section 252(i) and 47 C.F.R. Section 51.809, AT&T shall make available the entire Interconnection Agreement approved pursuant to 47 USC Section 252.

KDL and AT&T respectfully request that the TRA approve the Agreement negotiated between the parties.

AMENDMENT TO INTERCONNECTION AGREEMENT BY AND BETWEEN

BELLSOUTH TELECOMMUNICATIONS, LLC D/B/A AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA, AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI, AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA, AND AT&T TENNESSEE AND

WINDSTREAM KDL, INC.

The Interconnection Agreement by and between BellSouth Telecommunications, LLC d/b/a AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA, AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI, AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA, AT&T TENNESSEE (collectively "AT&T SOUTHEAST REGION 9-STATE) and Windstream KDL, Inc. (f/k/a Kentucky Data Link, Inc.), is hereby amended as follows.

WHEREAS, AT&T SOUTHEAST REGION 9-STATE and Kentucky Data Link, Inc. ("Kentucky Data Link, Inc.") are the parties to that certain "Interconnection Agreement" effective as of July 15, 2007 (the "Agreement"); and

WHEREAS, Kentucky Data Link, Inc. has changed its name to "Windstream KDL, Inc.", and wishes to reflect that name change as set forth herein.

NOW, THEREFORE, in consideration of the mutual promises contained herein, <u>AT&T SOUTHEAST REGION 9-STATE</u> and Windstream KDL, Inc. hereby agree as follows:

- 1. The Agreement is hereby amended to reflect the name change from "Kentucky Data Link, Inc." to "Windstream KDL, Inc.".
- 2. AT&T SOUTHEAST REGION 9-STATE shall reflect that name change from "Kentucky Data Link, Inc." to "Windstream KDL, Inc." only for the main billing account (header card) for each of the accounts previously billed to Kentucky Data Link, Inc. AT&T SOUTHEAST REGION 9-STATE shall not be obligated, whether under this Amendment or otherwise, to make any other changes to AT&T SOUTHEAST REGION 9-STATE's records with respect to those accounts, including to the services and items provided and/or billed thereunder or under the Agreement. Without limiting the foregoing, Windstream KDL, Inc. affirms, represents, and warrants that the ACNA and OCN for those accounts shall not change from that previously used by Kentucky Data Link, Inc. with AT&T SOUTHEAST REGION 9-STATE for those accounts and the services and items provided and/or billed thereunder or under the Agreement.
- 3. Once this Amendment is effective, Windstream KDL, Inc. shall operate with AT&T SOUTHEAST REGION 9-STATE under the "Windstream KDL, Inc." name for those accounts. Such operation shall include, by way of example only, submitting orders under Windstream KDL, Inc., and labeling (including re-labeling) equipment and facilities with Windstream KDL, Inc.. Any change in Carrier's name including a change in the "d/b/a", or due to assignment or transfer of this Agreement wherein only Carrier's name is changing, and no Carrier Company Code(s) (ACNA/CIC/OCN) are changing, constitutes a Carrier Name Change under this Section. For any Carrier Name Change, Carrier is responsible for providing proof of compliance with industry standards related to any Company Code(s), including notification of the name change to the appropriate issuing authority of those Company Code(s) as required. Carrier must submit the appropriate service request to AT&T SOUTHEAST REGION 9-STATE to update Carrier's name on all applicable billing accounts (BANs), and Carrier is responsible for all applicable processing/administration and nonrecurring charges for each service request. Should Carrier desire to change its name on individual circuits and/or End User records, Carrier must submit the appropriate service request(s) to AT&T SOUTHEAST REGION 9-STATE to update Carrier's name on individual circuits and/or End User records, and Carrier is responsible for all applicable processing/administration and nonrecurring charges for each of those service request(s).
- 4. For purposes of this Agreement, Section 20 of the General Terms and Conditions of the Agreement is deleted and replaced with the following:

- 20. Notices
- 20.1 Notices given by one Party to the other Party under this Agreement shall be in writing (unless specifically provided otherwise herein), and unless otherwise expressly required by this Agreement to be delivered to another representative or point of contact, shall be pursuant to at least one of the following methods:
 - 20.1.1 delivered personally, delivered by express delivery service or mailed via certified mail or first class U.S. Postal Service, with postage prepaid and a return receipt requested.
 - 20.1.2 delivered by facsimile provided CLEC and/or <u>AT&T-22STATE</u> has provided such information in Section 20.3 below.
 - 20.1.3 delivered by electronic mail (email) provided CLEC and/or <u>AT&T-22STATE</u> has provided such information in section 20.3 below.
- 20.2 Notices will be deemed given as of the earliest of:
 - 20.2.1 the date of actual receipt;
 - 20.2.2 the next Business Day when sent via express delivery service;
 - 20.2.3 five (5) calendar days after mailing in the case of first class or certified U.S. Postal Service; or
 - on the date set forth on the confirmation produced by the sending facsimile machine when delivered by facsimile prior to 5:00 p.m. in the recipient's time zone, but the next Business Day when delivered by facsimile at 5:00 p.m. or later in the recipient's time zone.
 - 20.2.5 notice by email shall be effective on the date it is officially recorded as delivered by delivery receipt and in the absence of such record of delivery, it shall be presumed to have been delivered on the date sent to CLEC by AT&T-22STATE.

In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
- 8. This Amendment shall be filed with and is subject to approval by the applicable state Commission and shall become effective fifteen (15) calendar days following approval by such Commission ("Effective Date").
