(“Piedmont” or the “Company”) and the Consumer Advocate and Protection Division of the Office of Tennessee Attorney General (“Consumer Advocate”) (collectively the “Parties”), through counsel, respectfully submit this joint status report. The Authority’s Notice of Filing Joint Status Report issued June 10, 2015 in the above named docket requires that the Parties file a joint status report on the progress of their discussions by June 30, 2015.

Piedmont and the Consumer Advocate report that they are working on finalizing documents and testimony setting forth and supporting what the parties expect to be terms for settling this Docket, subject to the approval of the Attorney General, appropriate approvals by the Company’s management and the execution of a stipulation and settlement agreement. Additional time is needed to complete these processes. Accordingly, the Parties propose the filing of another Joint Status Report on or before July 31 regarding the progress of discussions/settlement unless the Parties have filed settlement documents prior to that date.
